This AGREEMENT made and entered into on the date indicated on this document, by and between the Yale Area Chamber of Commerce, hereafter referred to as the "SPONSOR" and _____ representing _____, hereafter referred to as the "CONTRACTOR".

SPONSOR desires to present to the general public a BOLOGNA FESTIVAL during the dates of July 24, 25 and 26th in downtown Yale.

CONTRACTOR desires to locate in the downtown area during the dates indicated above for the purpose of selling its goods and/or services to the general public.

THEREFORE, SPONSOR and CONTRACTOR mutually agree to the following terms and conditions:

OBLIGATIONS OF SPONSOR:

1. SPONSOR will furnish to CONTRACTOR a location in the downtown area for CONTRACTOR'S concession operation along with the availability of some utilities and security. All specific locations and SPONSOR'S decisions as to such location will be final.
2. SPONSOR will allow CONTRACTOR a location to operate it's concession during the dates indicated above at hours not less than those operated by the festival and as agreed to by the SPONSOR.

OBLIGATIONS OF CONTRACTOR:

1. CONTRACTOR will furnish goods and/or services at the above mentioned location, dates and times as described as
